# 3. CONTENT AND PRESENTATION OF THE FINANCIAL OFFER

The Financial offer must be drawn up using the ", Price Offer from the list indicated under items 2.1 and 2.2. Prices must be quoted in Tanzania Shilling and include all expenses necessary, including delivery, to perform the contract.

If in addition to the price offered, the supplier applies a % discount, then it must be stated in the offer.

Please note: Prices are to be provided as per the volume, quantity and packing size described for each item in the "Committing Price Offer

## 4. CONTENT OF THE TECHNICAL OFFER

The Tenderer shall enclose with the Technical Offer all documents and information that will enable its offer to be assessed. Additional information included.

- Full company profile.
- Company registration documents i.e. Certificate of Incorporation, business license, TIN, VRN, Tax Clearance Certificate if any.
- BRELA registration of Companies detailed information certificate; and
- Any other related documents

### 5. PRICE

Prices submitted in response to this Call for Tenders must be inclusive of all costs involved in the performance of the contract. Prices shall be submitted only in Tanzanian Shillings.

### **6. PAYMENT ARRANGEMENTS**

Payments under the Contract shall be carried out within 30 days after an invoice is submitted to TMRC. Payments will be made after receipt and approval of the ordered goods. Each invoice must specify the specific items covered as per the relevant purchase order.

### 7. QUALIFICATIONS CRITERIA

- i. Interests suppliers must demonstrate prior experience in supplying similar items, financial stability, and compliance with quality standards.
- ii. Offer with the prices (detailed)
- iii. The timeline of the delivery.
- iv. The length of the warranty.
- v. The best quality compared to prices.
- vi. Evidence of holding a similar contract in the last two years.
- vii. Capability in providing similar services.
- viii. Bids submitted without specified prices, required documents above and outside the deadline will not be considered.
- ix. TMRC will select the supplier that best suits its needs based on the criterion "best quality compared to price".
- x. The existing supplier who wishes to be retained must apply afresh and submit up to date information; and
- xi. The above services/goods are intended to be awarded through a competitive tendering process in which a restricted number of suitable pre-qualified and experienced companies shall be invited to receive the tender documents.
